#### **Training Agreement**

I wish to become a Wyandotte County Extension Master Gardener Trainee and will be available for the classes beginning September through December. There is a \$125 fee for the training course and materials. Extension Master Gardeners are expected to provide recommendations based on research-based information, and to provide educational program assistance in support of the general County Extension educational program.

Extension Master Gardeners operate under the supervision of a trained Extension professional responsible for monitoring their performance and the progress of their continuing education.
