- Must be a Wyandotte County resident.

**Training Agreement**

I wish to become a Wyandotte County Extension Master Gardener Trainee and will be available for the classes beginning September through December. There is a \$125 fee for the training course and materials. I understand that if accepted into the Training Program, I am entering into a contract to return 40 hours of volunteer time on approved Extension Master Gardener projects during the calendar year following basic training course completion. I further understand that continuation as an active Extension Master Gardener in good standing requires a minimum of 25 volunteer hours annually on approved Extension Master Gardener projects.

I understand that Extension Master Gardener volunteers may not participate in the Wyandotte County Extension Master Gardener Program for personal gain or for commercial/professional purposes. Extension Master Gardeners are expected to provide recommendations based on research-based information, and to provide educational program assistance in support of the general County Extension educational program.

Extension Master Gardeners operate under the supervision of a trained Extension professional responsible for monitoring their performance and the progress of their continuing education.
